# SALICE

## 15 years Warranty (Cabinet Fittings)

Salice cabinet fitting products (herein limited only to cabinet door hinges, drawer runners and lift systems) are covered by a limited warranty for its functionality for a period of **15 years** from the date of purchase against any manufacturing defect of the products.

The terms and conditions covering this warranty are as follow:

- 1) Only genuine and original Salice products purchased from Kitch (M) Sdn Bhd are covered by the warranty.
- 2) The product warranty is valid for a period of **15** calendar years from the date of purchase from Kitch (M) Sdn Bhd or an authorized reseller of Kitch (M) Sdn Bhd.
- 3) The product must still be in the original furniture it was installed in and not transferred to another furniture.
- 4) The warranty is only valid for the original purchaser of the product with proof of purchase.
- 5) This product warranty covers the replacement of faulty products only. It does not include the removal nor installation of the product from the furniture it is installed in for replacement purpose nor any associated costs involved in the replacement.
- 6) This warranty is immediately void if any of the following conditions occur:
  - a) Improper installation not according to specified guidelines.
  - b) Improper usage of the product not according to its intended purpose.
  - c) Mishandling of the product that may give cause to defect arising from it.
  - d) Application of incorrect or unsuitable agents on the product resulting in defacement or defect.
- 7) This warranty also does not cover condition of the product that is part of normal 'wear and tear' due to prolonged usage or caused by natural disaster or resulting from negligence.
